"Industry 4.0 is the biggest structural change of the past 250 years — a transformation of scale, scope and complexity is unlike anything humankind has experienced before."





Current LOE Issues/ Tracking:


Contracting during an inflationary economy is having a profound impact on the Defense Industrial Base (DIB)

- Happening in a context: budget instability, pandemic, workforce challenges have weakened DIB
- Impact: ~\$50B in lost buying power of FY21-22 appropriations; ~\$42B needed to preserve FY23 Presidential Budget Request (PBR)
- AIA has identified compelling data/examples/anecdotes describing lost/departing vendors, price instability, labor/workforce turmoil (especially among medium & small companies), 'unwillingness to commit'
- DOD policies are well-intended, but have thus far been late, half-hearted, and inconsistently applied

Ukraine/Support to Partners and Allies

- Aid to Ukraine is broadening from near-term weapons for the fight to longer term defense posture and sustainment
- Increasing focus on defense trade: restocking US/allied stocks and supporting partners' shift from Russia
- Deputy Sec. of Def. Hicks's new Foreign Military Sales "Tiger Team" examining ways to speed U.S. equipment to allies





Source: DoD FY23 President's Budget and FY22 Appropriations



The AIA Executive committee directed the association to stand up a Digital Transformation Council as part of the Technical Operations Division

Product support provisions adopted into the FY23 National Defense Authorization Act, crediting the AIA PSC Policy Subcommittee's collaboration with SASC:

• In July 2022, the Senate Armed Services Committee (SASC) directed the Under Secretary of Defense for Acquisition and Sustainment to submit a S-Series feasibility and advisability report to the US Congress by March 1, 2023, with their assessment.



AIA Leonard Ross Memorial Award for Sustained Achievement


